What is the Alfred Dickey Library Foundation and what is its goal?

A growing community needs a growing library. The Alfred Dickey Library Foundation was incorporated in 2006 to help the Alfred Dickey Library develop and better serve the community. It is designated by the IRS as a tax-exempt organization under section 501 (c) (3) of the IRS code. The Foundation works with the library staff to improve the facilities, equipment, and services. Its goal is to make the library and its services as complete, convenient, and up-to-date as possible for everyone who makes use of this historic facility.

Who manages the Foundation?

A local Board of Directors manages the Foundation. It is made up of 7 members. At least 1 of the members of the Foundation Board of Directors must also be a member of the Board of Directors of the Alfred Dickey Library



Who may donate to the Foundation?

Any person or organization can donate to the Foundation. A basic membership entitles the person or representative of an organization to a one year membership in the Foundation and to a vote at the Foundation's annual meeting.
